ATTENTION COMPETITORS - Each competitor is responsible for supplying management with correct association numbers (USDF, United States Equestrian Federation) for horse, owner, rider, and trainer, before the day(s) of the competition. The scores of competitors who fail to supply correct numbers may not be counted toward national awards.

ENTRIES: All entries must be postmarked by March 11, 2011. Correct fees in full and a copy of all association numbers and a current Coggins Report (within 1 year) must accompany each entry form.

Late Entries: All entries must be postmarked on or before the closing date. Late entries will be accepted at the discretion of management and will incur a late fee of \$30.

ENTRY FEES: Office Fee: \$25 per entry plus Incomplete entry fee of \$10 (refunded if entry is complete upon arrival. For verification forms that you can print out, go to www.eqverification.org). USEF/Drug Fee per horse: \$15 (\$7 Drug / \$8 USEF). Class Fees as listed above. Qualifying entries add \$10 to regular class fee. Please clearly mark a Q behind your class number for qualifying tests. Non-competing horses must complete an entry & pay \$40 schooling fee plus office fee & stall fee. Class changes approved by management \$10. Competitors who are not members of the USEF and/or USDF, the following fees are charged by USEF and USDF. USEF non-member fee per rider, trainer, or owner: \$30. USDF non-member fee per rider, trainer, or owner: \$25.

STABLING FEES: There are 200 10x10 permanent stalls available with doors. Stall fee is \$95 for Fri-Sun. First bedding supplied. Additional bagged shavings available through Show Secretary at \$7 per bag. Extra nights arranged through Show Secretary. Stalls open at Noon on Friday. Stabling is mandatory per Clarcona Horseman's Park rules.

NO REFUNDS after the closing date (GR 311.1.7 exception "act of God" in which classes are canceled only those class fees will be refunded). Refunds before closing date will be issued for amount paid minus the \$30 office fee. Returned Checks will incur a \$35 return fee, if not rectified within 10 days the matter will be turned over to USEF for disciplinary action.

RIDE TIMES: Tentative ride times will be available online at www.orlandodressage.com by Wednesday evening, March 23rd. All ride times, including the pre-printed show program, are to be considered tentative until Noon on the day before the show day. Please check your ride times the morning of competition days, outside of the office on the results board for up-to-date times. You may also ask one of our Dressage Stewards. If you don't have online availability you may call the Show Secretary at 407-880-3882 after March 23rd. Show office will be open at Noon on Friday, March 25th and the phone number during the show will be 352-406-9886.

AWARDS: Ribbons will be awarded to sixth place. First place winners in classes of 3 or more will receive an award. Grand and Reserve Highscore Award to the highest scores received in each level that has 3 or more riders during the show (excluding Freestyle, Young Horse, Test of Choice classes, and Pas de Deux rides) No awards will be mailed unless arrangements have been made through the Secretary. New this year, special award to the highest scoring 15 year old or younger rider!

USDF/Dover Adult Amateur Medal: Awarded to the Adult Amateur rider who meets all eligibility requirements and who has achieved the highest score from the appropriate Second Level Test.

HIGH SCORE BREED AWARDS: A special award or ribbon will be presented to the high score ride of the following breeds (please include a copy of breed papers with your entry). Oldenburg, Trakehner, Hanoverian, Dutch, Westphalian, American Warmblood, Spanish Horse, and Non-Warmblood,.

RULES/WHIPS: All USEF rules apply; FEI rules will supersede USEF rules where applicable.

FREESTYLES: Freestyle class entries require copy of highest test at that level with a score of 60% or higher, to be submitted at time of entry. Riders should submit music to the announcer's booth the morning of ride. Music should be labeled with instructions and horse/rider names.

USEF TEST OF CHOICE CLASSES: Management will split a Test of Choice class into a Training & First Level TOC, and a & Second, Third & Fourth Level TOC class if there are 15 entries in any of the USEF TOC classes. Riders note that any test if offered on a particular day as Great American Insurance Group/USDF Qualifying, may not be offered as qualifying in a Test of Choice class on the same day.

OPPORTUNITY CLASSES: Opportunity Classes will be held in accordance with USEF GR331. Scores from these classes will not be included for any high point or year end awards. Horses entered only in these classes are exempt from USDF fees and the Federation fee (USEF), including the Equine Drugs and Medication fee but they are still subject to and must comply with the Drugs and Medication rules and may be selected for drug testing. Horses entered only in these classes are not required to have a Horse Identification (HID) or Recording Number but are to list the numbers if the horse has been assigned a Horse Identification (HID) or Recording Number. Riders only entering these classes are exempt from USDF and the Federation membership requirements and are not required to pay a non-member or breed/discipline fee but are required to list the Federation membership number if the participant is a member. Riders and horses may also enter Introductory classes with the same exemptions other than the drug testing fee (\$15). Cross entry to other classes is allowed but then all applicable fees and membership requirements apply.

FOOTING: Standard 20 x 60 m rings. Rings 1 & 4 are a Equi-rubber/Sand mix. Rings 2 & 4 are a clay/sand mixture. Two lunging rings, plenty of warm up areas available with the different footings & open grass areas.

DIRECTIONS: From I-4 E – Exit 92 onto SR 436. Go west to Apopka. Turn left on CR 435 S (Park Ave). Turn right on McCormick Rd (follow brown park signs). After one block turn right on Damon Rd. Go straight to park on right. Pass school, take **SECOND GATE** into the park. Stall assignments posted on right side after park entrance. **From South/North/West:** FL Turnpike toward Orlando north. Turns into toll road 429 to Apopka. Exit on West Rd. Turn left. At traffic signal turn right. At McCormick Rd (convenience store) turn right. At Damon Rd turn left. Pass school, take **SECOND GATE** into the park. Stall assignments posted on right side after park entrance. **Closest Major AIRPORT** (1 hr max) Orlando International (MCO).

RV HOOK-UPS: RV hook-ups available through Clarcona Horsemans Park. Electric and water is available but no septic. Bathrooms on showground have showers.

DOGS: Dogs are welcomed but must be on a 6' leash at all times! No expandable leashes. Any loose dogs will result in owner being charged \$50 that will be donated to the local Humane Society. Any dog becoming a nuisance will be asked to leave the grounds.

SHARPS CONTAINERS; There are sharps containers positioned in the center of each barn for the disposal of needles and/or other sharp disposable instruments, as per federation rule GR1210.4.

MANAGEMENT: The show management reserves the right to refuse, accept conditionally and/or cancel awards of prizes without claims for damages and to change order of classes or cancel or combine classes at its discretion if entries deem it necessary. Management also reserves the right to substitute judges or add judges only if necessary.

COMPETITORS PARTY: The fun-filled competitors party will be on Saturday after the last ride of the day. Come join your fellow competitors for fun, great food and refreshments! We always have a blast!

USEF MEMBERSHIP STATEMENT

Life, senior active and junior active members shall be eligible to participate in all classes at Regular Competitions, Eventing Competitions at the Preliminary Level or above and Combined Driving Competitions at the Advanced Level, Dressage, Reining and Vaulting Competitions and Endurance Rides. A nonmember may participate as a handler, rider, driver, owner, lessee, agent, coach or trainer at Regular Competitions, Eventing Competitions, Dressage Competitions, Reining Competitions and Combined Driving Competitions upon payment of a \$30 nonmember registration fee. Participants in the following classes are exempted from the Requirements of this rule: 1) leadline; 2) exhibitions; 3) games and races; 4) classes for 4-H members; 5) walk trot and academy classes (academy classes are classes limited to horses used regularly in a lesson program); 6) USDF introductory level tests, pas de deux and quadrille classes; 7) NRHA Endorsed Reining Competitions. 8) Opportunity classes, 9) citizens of other nations who have proof, in English, of current membership in good standing of their own National Federation, 10) USEA beginner/ novice division; and 11) assistant handlers in Dressage Sport Horse Breeding classes.

Motorized Vehicle Statement

In accordance with GR1301.7:

Minors who do not have a valid driver's license which allows them to operate a motorized vehicle in the state in which they reside will not be permitted to operate a motorized vehicle of any kind, including, but not limited to, golf carts, motorcycles, scooters, or farm utility vehicles, on the competition grounds of licensed competitions. Minors who have a valid temporary license may operate the above described motorized vehicles as long as they are accompanied by an adult with a valid driver's license. Violations of this rule will be cause for sanctions against the parent(s), guardian(s) and/or trainer(s) who are responsible for the child committing the offense. Penalties may include exclusion of the child, parent(s), guardian(s), and/or trainer(s) from the competition grounds for the remainder of the competition and charges being filed against any of the above individuals in accordance with Chapter 6. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule.

USDF Membership Benefits: USDF is dedicated to education, the recognition of achievement, and promotion of dressage. For details on member benefits, including educational programs, awards, and other opportunities, refer to the *USDF Competitor & Member Guide* or the USDF Web site at www.usdf.org.

Membership Requirements for USEF-licensed/USDF-recognized Competitions: Owners and riders, including foreign riders and owners who are not residents of the US, wishing to participate in a USEF-licensed/USDF-recognized competition as a rider or owner/lessee, must have either a USDF Group Membership, Participating Membership (PM), or have a USDF Non-Member (NM) identification number and pay the USDF NM fee. (Note: USDF business members can own horses but cannot compete as riders with their USDF BM.) Individuals cannot compete at a USEF-licensed/USDF-recognized competition with a USDF Education Membership.

Horses competing at USEF-licensed/USDF-recognized competitions must have either a USDF Horse Identification (HID) number or a USDF Lifetime Horse Registration (LHR). Proper credentials or verification certificates must be presented to the competition secretary.

Riders and owners wishing to participate in a USEF-licensed/USDF-recognized competition, and not able to present the competition secretary with verification of a USDF membership or NM identification, and USDF LHR or USDF HID, must complete a USDF Competition Affidavit Form and pay the \$5 affidavit filing fee. A copy of a completed affidavit form from another competition may also be used for verification purposes for up to 60 days. (Exception: Affidavits cannot be used at Great American Insurance Group/USDF Regional Dressage Championships.)

Exceptions:

- Horses competing only in Individual Breed Classes (IBCs) at DSHB competitions, sires and dams of horses in DSHB group classes, where those sires or dams are not actually competing in the same competition, horses competing only in breed restricted dressage or DSHB classes at Regular Competitions (e.g. all Arabian, all Friesian, or all Morgan classes), or in USDF Introductory Level tests, Pas de Deux, Quadrille, FEI ParaEquestrian classes, are exempt from this requirement. Also exempt are horses ridden in leadline, exhibitions, games and races, classes for 4-H members, walk-trot, academy and opportunity classes. For foreign-owned horses competing in a CDI, USDF accepts copies of the horse identification pages from an FEI passport in lieu of a USDF HID or LHR number.
- Riders and owners/lessees competing only in classes which are exempt from the USDF HID requirements are also exempt from the USDF NM identification number and NM fee requirements. Also exempt are handlers of horses competing in DSHB In-Hand or Group classes.

Memberships Defined

Participating Membership (PM): A membership issued to an individual directly by USDF. The membership year is December 1 through November 30. PMs are available for 1-year (\$75), 5-years (\$300), or life (\$1,500). A USDF Youth Participating Membership (YPM) is available for individuals who have not reached their 21st birthday by December 1 of the current membership year (\$60). A PM allows the member to compete at USEF-licensed/USDF-recognized competitions and to participate as a rider and/or owner/lessee for all Adequan®/USDF Year-End Awards, Great American Insurance Group/USDF Breeders' Championship Series Finals and the Great American Insurance Group/USDF Regional Dressage Championship program.

Group Membership (GM): A membership issued to an individual by USDF when the member name and dues are submitted to USDF through an affiliate Group Member Organization (GMO). The GM year begins December 1 and ends November 30. A GM allows the member to compete at USEF-licensed/USDF-recognized competitions and participate in the USDF Rider Awards program.

Business Membership (BM): A membership that runs December 1 through November 30 and is issued to a business or organization directly by USDF. The USDF BM (\$200) offers a wider variety of advertising benefits. BMs satisfy requirements of horse ownership only.

Education Membership (e-Membership): A membership issued to an individual directly by USDF. This online education only membership expires 12 months after the date joined. This membership type does NOT allow an individual to compete at a USEF-licensed/USDF-recognized competition.

Non-Member (NM) Identification Number: For each USDF NM owner/lessee and USDF NM rider there will be a USDF NM fee of \$25 and a USDF NM form per competition that must be collected by the show secretary and submitted to USDF along with the USDF Report of Fees document and the \$5 affidavit fee if the person cannot provide a copy of their USDF NM card. Owners/lessees or riders exempt from the NM number requirements are also exempt from paying the USDF NM fee. If there are multiple owners of a horse and all are NMs, only one of the owners must pay the NM fee. If the horse has at least one owner who is a current USDF member there is no NM fee assessed. Competition management will be invoiced for all applicable USDF NM fees not received with the USDF post competition paperwork, along with a report listing all USDF NMs. Competition management is then required to submit the NM fees within 30 days to the USDF. An individual with a USDF NM identification number is not eligible for any USDF membership benefits. Once a USDF NM number has been assigned, a USDF NM card can be obtained from the USDF Web site.

Horse Identification (HID) Number: A one-time tracking number for horses (\$25). Scores earned by a horse with an HID number will be recorded, but will NOT be counted towards Adequan®/USDF Year-End Awards. A horse with an HID number is not eligible to compete in Great American Insurance Group/USDF Regional qualifying or championship classes or Great American Insurance Group/USDF Breeders' Championship Series Finals. An HID number can be upgraded to a Lifetime Horse Registration (LHR) for a fee of \$70. If a horse has a USDF LHR it does not need an HID number. An HID number is a one-time fee that does not need to be renewed.

Lifetime Horse Registration (LHR): A horse with an LHR (\$95) is eligible for Adequan®/USDF Year-End Awards, and eligible to compete at Great American Insurance Group/USDF Breeders' Championship Series Finals and Great American Insurance Group/USDF Regional qualifying and championship classes, assuming requirements for the owner and rider are met. If a horse has an LHR it does not need an HID number. An LHR does not need to be renewed.

How to Join USDF

Applications for USDF Participating Membership (PM), Business Membership (BM), Horse Identification (HID) number, and Lifetime Horse Registration (LHR) may be found in the following locations:

- On the USDF Web site: www.usdf.org. You can submit the application online or download the form and fax or mail it to the USDF office.
- In the show office at USEF-licensed/USDF-recognized competitions classified by USEF as Dressage Competitions, and Regular Competitions which are open to all breeds.

The effective date of membership is the date the form and correct fees are received in the USDF office or, if applying at a competition, the date received by the competition secretary, provided the application is signed and dated by the competition secretary, member, and/or horse owner on that same day.
